

**Rules and regulations of the *PhoBiA Annual Nanotechnology International Conference*  
„PANIC 2019” international conference organized in the campus of Wrocław University  
of Science and Technology from 15 to 17.05.2019**

**I. General regulations**

1. Following Rules and regulations concern *PhoBiA Annual Nanotechnology International Conference* „PANIC 2019” in the campus of Wrocław University of Science and Technology organized by the Photonics and Bionanotechnology Association “PhoBiA” student research group, functioning in the Faculty of Chemistry and the Faculty of Fundamental Problems of Technology of Wrocław University of Science and Technology (Anna Lesiak tel. +48 798 872 827 – main coordinator).
2. The conference has a closed character and is not a mass event in the terms of Act of law about safety of mass events from 23.03.2009 (Logbook from 2015, position 2139).
3. The conference is addressed to students, doctoral candidates and researchers from inland and from abroad. The organisers do not take responsibility of any harm caused by inappropriate behaviour of participants.
4. Representatives of sponsors, partners and media patrons are also allowed to participate in the conference after informing the organizers.
5. The official Conference internet website is [www.panic.pwr.edu.pl](http://www.panic.pwr.edu.pl).
6. Within the framework of Conference, there will be lectures, a poster session and a photographic work exhibition on the occasion of the International Light Day.
7. Organizers and Security of the Event are allowed to refuse entrance and participation in the event to a person in a visibly drunken state, as well as a person breaking the rules and regulations of the Event. In such cases, administrative workers of Wrocław University of Science and Technology have right to record data of the participant from their student card, personal ID or passport and pass it on in the form of a note to the Vice-Rector for Student Affairs, Vice-Dean for Student Affairs of the Faculty of Chemistry, or to the PANIC 2019 organizing staff (Kamila Drzozga, tel. +48 792 803 118).
8. Organizers or administrative workers on their behalf can refuse entrance to the area of the conference to a person stated to disrupt public order.
9. Aim of the following rules and regulations is to provide safety by determining behaviour rules of participants of the event and use of the available area by them.
10. During the whole PANIC 2019 Conference it is forbidden to approach the embankment of the Odra river in the Boulevard of Wrocław University of Science and Technology.
11. Participation in the event is equivalent to acceptance of this document. The participant accepts hereby that in instance of disobedience of the Rules, they can be deprived of the right to take part in the event

**II. Organizational and regulatory rules in the area of the event**

1. During the event it is forbidden to carry in, consume and distribute alcohol and other intoxicants; it is also to remind that smoking cigarettes (including e-cigarettes) is strictly forbidden in the area of the University.
2. In instance of causing harms by the participant, a report of the incident will be recorded, in which the participant will be obliged to repair or cover costs of repair. In case of intentional harm, the participant will be immediately removed from the event.

3. In the area of the event it is forbidden to sell, advertise (apart from advertisements of the PANIC 2019 Conference sponsors' advertising materials, previously accepted by the organizers), canvass or host a fundraiser.
4. It is forbidden to hang or expose banners with vulgar content or connected with sport clubs, subcultures, hate, aggression, etc.
5. Every malaise, injury or burn should be immediately reported to the PANIC 2019 Conference organizing committee, who will contact Emergency Services and provide First Aid.
6. A First Aid Kit will be available at the conference reception in the D-21 building (Kamila Drzozga, tel. +48 792 803 118).

### **III. Rights and duties of the participants**

1. The participants must register on the conference website [www.panic.pwr.edu.pl](http://www.panic.pwr.edu.pl). After sending abstracts and their acceptance by the organizers, the participants are obliged to pay a conference fee: students 80 Euro (before 15 March 2019, "Early bird") or 100 Euro (after 15 March 2019); others 160 Euro (before 15 March 2019, "Early bird") or 200 Euro (after 15 March 2019). Wrocław University of Science and Technology students can apply for a reduction to 50 Euro, independently on the registration time.
2. The whole fee will be entrusted to conference tasks.
3. The participant is obliged to register in the first day of the conference to confirm their presence.
4. Transport, accommodation and board costs must be covered by the participant from their own means.
5. The organizers do not take responsibility for any lost, damaged or stolen belongings.
6. The organizers do not take responsibility for inappropriate behaviour of the participants of the event.
7. By registration, the participant consents to use their personal data for conference purposes.
8. The organizers can record videos and pictures during the whole event. Participation in the event is equivalent to consent of the participant to use their image in informational and advertising materials of PANIC 2019 Conference. A person who does not allow to use their image is obliged to inform the organizers under e-mail address [phobia@pwr.edu.pl](mailto:phobia@pwr.edu.pl) at least 2 days before the event.
9. Every participant is obliged to follow instructions of organizers, administrative workers and event coordinators, and to obey the Rules and regulations.
10. Participants will be obliged to stay in rooms appointed by the organizers or coordinators.
11. Every participant is obliged to acquaint themselves with the Rules and regulations and with the map of the Campus of Wrocław University of Science and Technology.
12. The organizers and administrative workers do not take responsibility for the effects and consequences of disobedience of the above mentioned rules and other instructions of the organizers, as well as orders of order and safety services.

#### **IV. Final provisions**

1. The organizer stipulates a right to changes in the Rules and regulations.
2. The Rules and regulations were recorded in two language versions (Polish and English).
3. In instances not regulated by this document, the Civil Code will be followed.
