Terms and Conditions of the International Conference PANIC 2024 (PhoBiA Annual Nanotechnology International Conference) organized on the campus of Wroclaw University of Science and Technology, buildings D-21, C – 18 from 15.05 to 16.05.2024.

## I. General provisions

- 1. These terms and conditions (hereinafter referred to as the "Terms and Conditions") apply to the International Conference "PhoBiA Annual Nanotechnology International Conference" (hereinafter referred to as the "PANIC 24 conference" or the "event"), organized between 15.05 16.05.2024 on the campus of Wroclaw University of technology by the Photonics and Bionanotechnology Association "PhoBiA" operating at the Faculty of Chemistry of Wroclaw University of Technology (dr hab. inż. Katarzyna Matczyszyn, Prof. PWR Tel. 71 320 40 08 Head of the PANIC 2024 conference, Marharyta Hancharova Tel. 71 320 38 67 main coordinator, Kamila Łupińska Tel. 509 542 430 Auxiliary coordinator, Karolina Saczuk Tel. 887 499 212 Auxiliary coordinator, Mikołaj Tkotz Tel.695 279 452-Auxiliary coordinator; hereinafter referred to as "event coordinators"), hereinafter referred to as "organizer".
- The purpose of these Terms and Conditions is to ensure the safety of the PANIC 2024 conference by defining the rules of behavior of people present at the event and their use of the area where it is organized.
- 3. The PANIC 2024 conference is closed and does not constitute a mass event within the meaning of the act of 23 March 2009 on the safety of mass events (i.e. Journal of Laws of 2015 item 2139).
- 4. The topics of PANIC 2024 are photonics, nanotechnology, biotechnology and related fields.
- 5. The PANIC 2024 conference is addressed to 45 participants: a maximum of 25 doctoral students from the Doctoral School of Wroclaw University of Technology and from outside the Doctoral School of Wroclaw University of technology, as well as a maximum of 20 students of the bachelor's and master's degree who, after completing the application form and acceptance, acquire the status of participants.
- 6. The Organizer provides 20 places for posters for registered participants during the poster session, which will be held on the premises of building C-18 on 16.05.2024.
- 7. The status of a participant is also granted to all professors invited to the PANIC 2024 conferences participating in the PANIC 2024 conference as speakers.
- 8. Participants of the PANIC 2024 Conference receive a certificate of participation in the PANIC 2024 conference.
- 9. The PANIC 2024 conference can also be attended by representatives of media patrons, having informed the organizer in advance, but they are not defined as participants.
- 10. The official website for registration of PANIC 2024 conference participants is "conf.e-science" Wroclaw Network and Supercomputing Centre.
- 11. The PANIC 2024 conference will include lectures delivered by invited professors, as well as a poster session, oral presentations and short oral presentations called "shotgun".
- 12. The organizer has the right to refuse entry and stay at the PANIC 2024 conference to persons who are apparently drunk or under the influence of narcotic drugs, as well as violating the provisions of these Terms and Conditions. In such cases, a note will be drawn up, which will be forwarded to the doorman of building D-21 or C-18.
- 13. The organizer or employees of the Wroclaw University of Science and Technology Administration on its behalf have the right to refuse a person entry to the PANIC 2024 conference if it is found that a person disrupts public order and order in particular in the manner specified in point 12.
- 14. Participation in the event is tantamount to acceptance by the participant of these regulations. The participant of the event hereby acknowledges that in case of non-compliance with the terms and conditions, he / she / they will be deprived of the right to participate in the event.

## II. Organizational and order rules at the PANIC 2024 conference

- 1. During the PANIC 2024 Conference, all participants of the event are prohibited from bringing and distributing alcohol or other narcotic substances; it is also recalled that the University is prohibited from smoking cigarettes (including e-cigarettes).
- 2. In the event of damage caused by the participant, an incident report is drawn up, in which he undertakes to repair them or cover the costs of their repair. In case of intentional damage, the participant will be immediately removed from the PANIC 2024 conference after the minutes are written.
- 3. At PANIC 2024, it is prohibited to sell, advertise, acquire or hold fundraisers.
- 4. It is forbidden to post and display on the PANIC 2024 Conference Grounds banners and banners containing vulgar content or inciting hatred, aggression, etc.
- 5. If participants feel unwell, have an injury, cut or burn, they must report it to the PANIC 2024 organizer, who will notify the Emergency Services.
- 6. A first aid kit will be available at the concierge desk in building D-21 and C-18.

## III. Rights and obligations of PANIC 2024 conference participants

- 1. Participants register through the service "conf.e-science" Wroclaw Network and Supercomputer Center, information about the internet address for registration will also be available on the official website of the Scientific Chapter "PhoBiA" www.phobia.pwr.edu.pl. After submitting the registration forms and abstracts of speeches, the process of accepting applications of up to 25 doctoral students from the Wroclaw University of Technology and from outside the Wroclaw University of technology, as well as applications of up to 20 students of bachelor's and master's degrees, who, after filling out the application form and acceptance, acquire the status of participants who will take part in the PANIC 2024 conference.
- 2. Incomplete application forms and forms containing summaries not related to the topic of the PANIC 2024 conference will not be considered by the organizer of the PANIC 2024 conference.
- 3. Participants are required to register on the opening day of PANIC 2024 to confirm their attendance.
- 4. The organizer at the Wroclaw University of Technology provides food for participants of the PANIC 2024 conference during lunch and coffee breaks.
- 5. The organizer covers the cost of travel and accommodation for invited professors.
- 6. The organizer does not bear the cost of printing posters, the participant covers them from their own funds.
- 7. The organizer is not responsible for items belonging to the participants of the event that may be lost, destroyed or stolen during the PANIC 2024 conference.
- 8. The organizer is not responsible for inappropriate behavior of participants. About gross acts: violence, vandalism, theft, deprivation of dignity, injury to good name, violation of personal inviolability, misdemeanors threatening the safety of other participants or purposeful actions to the detriment of another participant or organizers, the university authorities will be informed, and in justified cases the police will be notified.
- 9. Participants of the event bear full material responsibility for damage caused by them on the territory of the event in relation to other participants, as well as for damage caused to the property of the organizer or third parties whose property is located on the territory of the event with the consent of the organizer.
- 10. It is forbidden to destroy signs and information boards, advertising media, and equipment located on the territory of the event, etc..
- 11. By registering, participants agree to the processing of personal data for the purposes of the PANIC 2024 conference.
- 12. The organizer and media patrons may record the course of the event for Documentary or advertising purposes. The organizer or persons authorized by him may use such a recording or its fragment, including the image of a participant or other person present at the event, without time and territorial

restrictions, without having to pay remuneration for the use of the image specified in Article 50 of the act of 4 February 1994 on copyright and related rights (i.e. Journal of Laws of late. Ed.). Participants or persons present at the event agree to the preservation and dissemination of their image, recorded during the event. A person who does not express such consent is obliged to inform about this fact at phobia@pwr.edu.pl, no later than 2 days before the start of the event.

- 13. Each participant of the event is obliged to strictly follow the instructions of the organizer, administration staff, event coordinators and accept these Terms and Conditions.
- 14. Participants of the event will be required to stay in places designated by the organizer of the PANIC 2024 conference.
- 15. Each participant of the event is obliged to read these rules of PANIC 2024 Conference and the map of the campus of Wroclaw University of Science and Technology.
- 16. The organizer and employees of the university administration do not take responsibility for the consequences and consequences of actions resulting from non-compliance with the above provisions and orders of the organizer and the orders of the services responsible for security and order.

## IV. Final provisions

- 1. The organizer reserves the right to change these regulations.
- 2. The organizer reserves the right to cancel the event or change the place and / or date, if it results from reasons beyond its control.
- 3. Resolving any disputes and making decisions that are not covered by these Terms and Conditions, as well as the right to interpret all provisions of these Terms and conditions, is exclusively for the organizer.
- 4. In matters not regulated by these regulations, the relevant provisions of the Civil Code shall apply.
